allowing communities to connect more directly with how God moves in the LAC region, it also engages with those who have not yet heard the Gospel. With a sincere passion for connecting with new people and capturing moments that normally go unseen, her work aims to visibly demonstrate spreading the Gospel, planting Lutheran churches and showing mercy in the far-flung corners of Latin America.

Serving as a missionary since 2017, Johanna spent the majority of her first year on the mission field in Asia before continuing in the LAC region. Her work has taken her across five continents where she has not only been able to capture wild and remote places, but also humbly embrace different cultures and people in some of the most densely populated places in the world. She has a Bachelor of Arts degree in graphic design, public relations, photography and communications. Johanna is very close to her loving family, and she enjoys the outdoors and hiking in the mountains. Any gifts received in excess of a worker's requirement for a given year are held for that worker until needed. Should a worker's service conclude for any reason, the funds remaining in the restricted account will be transferred to one or more eligible LCMS international workers who most closely fulfill the restrictions of the original gift. With documented donor permission, a restricted gift can also be utilized to support international work budgeted by the LCMS. Your gift is tax deductible to the extent permitted by law.
